I heard from a few folks they weren't going to monitor boxes this year because of the virus. They couldn't risk it. No problem. We don't want anyone that may be in the high risk category going out if they feel compromised doing so. For me it meant taking on another trail to monitor just south of me. I can monitor it when I'm out on my bike. I ride down and check my small trail at Elver Park then go south on the bike trail to Badger Prairie Park. I have a saddlebag for any tools I need but mostly I take a cell phone pic and transfer the info when I get home to my paper form. It's a great way to get outside, get exercise and get my boxes checked.

Having monitored trails for over 20 years now I thought

I'd seen everything. Then I found 2 unusual Tree Swallow nests at Elver Park. One is made of pine needles only and has eggs but the hen did not line the nest with feathers! (Yet) Another Tree Swallow nest was made from grass and again eggs laid but no feathers line



the nest. It may be that the hens will add feathers after the full clutch is laid but in my experience this is a first.

On my trail at Brigham County park I have a white egg laying hen. First one in over 15 years. Last time I had one was at Lake Kegonsa State Park when I monitored the trail there. Only about 6% of bluebird hens lay white eggs.

Now if I could just get a haircut.

Even the Eastern Bluebird Can Be Affected By This **Pandemic!**

No, our bluebirds are not carriers of Covid 19. Yes, their nesting success may be. What am I talking about?

My primary trail of 35 boxes is on a golf course. During the beginning of March, I do what most of us do: added some boxes, repaired some, moved some and replaced some. Nothing new here at all. I actually found two bluebird pairs sitting on nesting boxes in mid March. It looked encouraging for the start of this year.

However, when I went to check my boxes for the first time for nesting activity at the end of March, I received a surprise. I was forbidden to go on the course. The course's general manager closed the course as dictated by the governor and issued an order that no non-employee will be allowed on the course until they decide to reopen. The Green's Superintendent, a huge supporter of my efforts, argued that what I did was important, but to no avail. Ouch. It was implied that

I would be arrested for trespassing. Really!

The general manager has been there for several years and has made it clear that he would rather see my bluebird boxes be taken off the course. The two former general managers were very happy to have bluebirds and went out of their way to tell me so. This new young manager said he has never seen a bluebird and questioned whether they were around. The course maintenance person let him know otherwise. Bluebird nesting and monitoring at this course has been going on for 19 years. Some of you may recall Gary Gaard, who I believe was the first.

My best year on this site saw over 3 bluebird fledglings per box. This does not count the other species. Last year saw 1.8.

I'm confident that I will be allowed back on the course soon. Probably by the time you read this I hope. I also hope no one else has experienced this disruption as well.

There is a lesson here. Most people do not have a clue as to what and why we do this chore of monitoring nests and they also have no idea about the

peril of the Eastern bluebirds and the need to help them. I have given lessons to golfers about what we all do for the last 12 years. Most are interested and non-knowledgable about our organization. I have received huge numbers of support from golfers on this course and many seek me out when they are playing.

Thank you all for your work and I know you are spreading the word.

The Triple Threat

Bluebird nests and chicks face a triple threat to survival: 1) raccoons, 2) black flies and ants, and 3) house sparrows. While an ounce of prevention goes a long ways, sometimes a healthy dose of cure is needed to keep these pests under control.

Raccoons can wreak havoc almost anytime from egg laying through fledging. They quickly acquire a taste for eggs and chicks. To prevent trouble, make sure the nest box entrance is protected by a Noel wire guard or a wooden block extension. Also, make it difficult for these bandits to climb the mounting pole by greasing it. Keep the pole away from a fence or post that gives this wily predator a leg up.



Black flies can suck the life out of chicks by repeatedly biting them for a blood meal. Female flies are attracted to the CO, given off by incubating hens or immobile chicks. Ants are attracted by egg residue and can harass chicks to exhaustion and death. Both black fly and ant infestations can be prevented by using a diluted concentration of Permethrin-10 insecticide. Spraying the nest box entrance and all cracks both inside and out will discourage these pests. If there are eggs or chicks in the box, put a small clear jar over them before spraying. In a week, repeat the spraying but only on the outside of the box. Trim weeds and grass around the pole.

House sparrows are especially nasty because they bully bluebirds from the nest boxes and sometimes kill the males. Locating nest boxes away from livestock feeding areas and homes usually prevents having a problem with this invasive species. However, if a male sparrow becomes an issue, the best solution is to install a Van Ert trap. Properly used, this trap allows you to humanely live catch a sparrow for removal. Accidently trapped bluebirds can be released unharmed. Order traps online by going to www.vanerttraps.com or call 515.418.3757.

We thank each of them for their many years of service to BRAW and their efforts to improve the status of bluebirds throughout Wisconsin.

Merely listing your contact info so someone can call and ask a simple question about bluebirds may be all you choose to do. Each coordinator may decide for themselves how active they want to be. Choosing to give talks and presentations to groups interested in learning about bluebirds, or assisting others in setting up bluebird trails after finding suitable nesting habitat are measures that can enhance the efforts we all can take to advance the future success of bluebirds.

Jack Bartholmai, Dodge County

On Leap Day, February 29th, I presented videos and photos of cavity nesting ducks, highlighting the leaping of Wood Ducks, Hooded Mergansers, and Bufflehead young that were on my nest box trails in Dodge Co.

On March 3rd, I gave a presentation of the Life History of the Eastern Bluebird to the Atwood Conservation Club.

Patrick Ready, Dane County

My calendar was lined up with bluebird presentations but all were cancelled due to the pandemic. I was able to accomplish a few things anyway. I was able to get new boxes for Holy Wisdom in Middleton. The trail there needed revamping and old boxes replaced. BRAW donated 5 boxes and a generous donor bought 12 boxes for the trail. All are NABS Style boxes made by BRAW member Fred Craig from Holman. The trail will have a new monitor and data will be reported to BRAW in September.

A couple of my trails I manage were in need of new monitors so I

recruited them before the season started. Our new membership chair Valerie Van Winkle was helpful in getting a new monitor for the Oaks Golf Course in Cottage Grove. A birding friend took over a small trail at Goth Park.

Steve Lang has taken over monitoring the trail at Token Creek County Park. He has had a super start to the season and I have been answering his questions. Steve finds the darnedest things. He sent me a photo of a wren nest with Tree Swallow eggs! Must

have been a battle for the box and guess who won? He has also helped some other monitors by replacing old boxes and getting trails in order that were "left go" for too long. Thanks Steve for all your help.

I monitor 3 trails myself and things were slow to get going but now things are picking up.

Dave Misterek, Winnebago County

Hi Gene, thanks for your efforts. I am Dave Misterek, coordinator for Winnebago County. My wife, Christine, and I have been busy getting our bluebird trail at Utica golf club ready for the season. We have added 5 birdhouses for a total of 43 houses. We look forward to a good season.

Jim Beix, Pierce County

On March 7th Lowell Peterson (St. Croix Co.) and I presented a bluebird program at Freedom Park Center in Prescott. Nearby Ellsworth had requested a presentation also so Lowell asked that Ellsworth people come to the Prescott presentation as the towns are only 10-15 miles apart. About 50-55 adults and children attended. A local craftsman had made NABS nest box assembly possible for attendees after the talk. Our formal presentation included bluebird lifecycle, different nest box styles, predator guards, box placement, and monitoring.

Lowell, Jim Higgins and I had planned a similar program for InterState Park in St.Croix Falls but the pandemic forced postponement of this presentation.

Mary Hollebach, Washington County

We held our Bluebird Box Building Workshop on Sat. March 14th just before the governor's orders came out to limit group activities in the state. 13 people attended including a couple of grandparents with grandchildren. What a nice family activity! Last week a bluebird monitor in Hartford reported finding two bluebird nests in her boxes on the golf course. I found two bluebird nests as well last week in boxes at Riveredge Nature Center. Hope the birds hold off with other nesting activities until it warms up again!

Rita Gundry, Eau Claire County

Eau Claire County endured an 8.5-10 inch snowstorm on Easter Sunday, followed by unseasonably cold weather, dropping into the teens overnight.



That seems to have halted all bluebird progress in this area. Checking with other bluebirders, they are having the same situation. Prior to the storm, we had a number of completed nests and some just started. Now 10 days since the storm has passed and no eggs are appearing in any of the nests. Concerned that snow most likely covered all available food, my brother, Larry Liegel, also a BRAW member, and I, put feeding stations near the site of completed nests. We used Wild Delight for Bluebirds...an advanced formula called BUGS & BERRIES. In addition to sunflower and safflower seeds, it contains dried black soldier fly larvae, dried mealworms, dried darkling beetles, raisins, cranberries and cherries. Most of the stations were emptied of food in a few days. Of course, other birds may have enjoyed it, as well. We are in hopes the bluebirds will return and claim the nests they built and continue with the mission of propagating their species.

Because of COVID-19, the two lectures Larry and I had planned were postponed. We expect to present to the Eau Claire Master Gardener and the Chippewa Valley Learning in Retirement groups when the state lifts restrictions for meeting.

Don Pritzl, Kewaunee County

Not much happening because of the virus. I was scheduled to have a display at the Bird City Algoma Day on April 18, but that was canceled. I have been closing all my boxes, moving some and put up a couple new ones. Looking forward to the

coming season. Saw my first bluebird, a beautifully colored male, on March 27, but haven't seen many since. Weather has been cold and windy so I don't think any nest building has started yet.

I'm excited that the 2020 Annual Meeting could be in NE Wisconsin. Hoping for a "normal' summer.

Bob Butzer, Vilas County

I have been getting the boxes cleaned and ready with hopes that the bluebirds **don't** come back for awhile. We're having freezing nights and frequent dustings of snow.

Gene Birr, Oconto County After Cordula Van Den Heuvel and

I gave a presentation to a standing-room-only crowd of 130 folks at the hardware store in Shawano in February, we spoke to 20 people who attended her Bird City event at the library in Oconto a week later. But then the current virus pandemic forced my annual talk at the WBU store in Green Bay to be canceled in mid-March.

Della and Gerry Clabots of Suamico have agreed to take over the 35 box trail that **Melissa McNeil** has monitored there for the last five years. They continue the legacy of our former **Brown County Coordinator**, **Joanne DeVetter** who established that trail over ten years ago.

I have prepared 60 nest boxes, ready for use by local monitors who may need them. **Barb Allen** has taken 12 skylight boxes to use on her golf course trails which are often bothered by House Sparrows. In late March, I assisted **Sue Clairmont** in re-working two of her trails near Pulaski. We repaired roofs on several boxes, straightened poles on others and replaced some with skylight boxes.

My first observation of a bluebird nest contained 6 eggs already on April 10 on my brother's farm near Oconto Falls. Two weeks later when I monitored the other 20 boxes nearby, this 6-egg nest was still the only box with a bluebird nest. On another trail there were bluebird nests in 3 of the first 4 boxes, then nothing in the next ten in a row, and only 2 of the 18 on my golf course trail had bluebirds initially.

Getting to Know Your County Coordinator Don Pritzl, Kewaunee County

I have been the coordinator of Kewaunee County since the mid-90's and have the county pretty much to myself. I don't think there's another person monitoring a bluebird trail in the county.

I've spoken to many groups over the years—Boy Scouts, 4-H clubs, Science clubs at the high school, etc. Some of these groups get enthusiastic, build boxes, put them up and then forget about them. I'd rather they not put them up at all if they're not going to monitor them. I've held meetings and trail walks for the public and the same people show up, and they're as old or older than me.

I may sound pessimistic, but the old adage, "you don't miss something you never had" seems to apply here. The younger people have other interests that don't include outdoor activities other than sports. I put articles in the paper occasionally and I have a booth at the Bird City Algoma event each April.

I've had some success and a lot of satisfaction on my bluebird trails over the years. I started with just a few boxes in 1992, have had as many as 75 at one time, but have scaled back in recent years. I had 58 boxes this past year with 52 BB nests; 43 were successful, had 216 eggs and fledged 178 bluebirds. Over the years almost 4000 bluebirds have fledged. I've had the same problems that everyone has had. Sparrows are always a problem and wrens are increasingly taking over boxes. I've moved some boxes, but I have trouble finding suitable habitat within reasonable travel distance. Urbanization has taken some of my prime spots, too.

I've had boxes stolen, run over by cars, demolished by farm equipment, shot full of holes and one on a golf course was stuffed with old balls!

I am 78 years old and find it increasingly difficult monitoring my boxes. Most are on roadsides and the deep ditches give me trouble. I will continue as long as I am able, but have been unable to get anyone interested to take over or to get the younger generation interested.

BRAW Summer Financial Report



Make a Predator Guard

Materials:

1 x 4" pine or cedar board Hardware cloth cut to 16"x6" 3 Screws 1-1/2" long

Tools:

Staple Gun

Drill


Hammer (to pound staples down firm) Cut the wood to 4-1/2" length


Drill a 1-1/2" entrance hole or an oval hole in the piece.


Starting on the bottom wrap the hardware cloth around the wood piece stapling it several times as you go. Drill 3 holes for screws in the wood piece for

easy fastening to the box.










The wood block is optional. You can attach the wire directly to front with several screws and washers but the block of wood makes a sturdier guard.
